Saudi Summer Excellence Awards 2024

Terms and Conditions

Section One: Eligibility, Qualification and Submission

1. Eligibility for Participation

- a. The submitted entry shall adhere to all conditions and criteria specified for each award category/division for which the participant is applying.
- b. The participant shall fully complete all required information and submit all necessary documents.
- c. Age of participants shall be 18 years or older. Employees of the Saudi Tourism Authority and their first-degree relatives are ineligible to participate.

2. Applying for Multiple Award Categories/Divisions

a. The participant is permitted to apply for a maximum of two award categories/divisions, provided that a separate application form is submitted for each.

3. Restrictions and Disqualification

- a. Group submissions are not permitted; only individual entries are eligible for participation in the award.
- b. The participant may not submit more than one entry per category/division. Any participant found in violation of this rule shall have all their entries disqualified.
- c. The submitted entry shall be created within a maximum of three (3) months prior to the submission date.
- d. The Saudi Tourism Authority reserves the right to exclude any submission it deems inappropriate, offensive, unrelated to the competition, or failing to meet the specified evaluation criteria.

Section Two: Terms and Conditions

By submitting an entry, the participant agrees to the following terms and conditions:

- 1. Intellectual Property Rights: The Saudi Tourism Authority retains all intellectual property rights to the submitted materials, including but not limited to images, videos, texts, and other creative works.
- 2. Copyright Licenses: The participant grants the Saudi Tourism Authority a non-exclusive, irrevocable, and perpetual license to use the submitted materials for any purpose related to the promotion of Saudi tourism, including but not limited to publication online, in print materials, and local, regional, or global media.
- 3. Liability Disclaimer: The Saudi Tourism Authority shall not be held liable for any damages, losses, or injuries arising from or in connection with participation in the Saudi Summer Excellence Awards 2024 or the use of submitted materials.
- 4. Disputes: Any disputes arising from or related to the Saudi Summer Excellence Awards 2024 shall be governed by the laws of the Kingdom of Saudi Arabia.
- 5. Right to Amend: The Saudi Tourism Authority reserves the right to amend these terms and conditions at any time without prior notice.
- 6. Content Ownership: Any submitted content shall be original and shall not infringe upon the copyright or trademark rights of any third party.
- 7. Cancellation of award related events or ceremonies: The participant acknowledges that the Saudi Tourism Authority shall not be responsible for the cancellation or rescheduling of award-related events or ceremonies, nor shall it be obligated to provide a replacement award or compensation in case of any cancellation.
- 8. Prize Collection Deadline: All prizes shall be delivered within a maximum of thirty (30) working days from the date of the announcement of winners. The Saudi Tourism Authority reserves the right to award the prize to an alternate winner or withhold the prize entirely if the original winner fails to claim it within the specified period in this clause.
- 9. Proof of Identity: Prizes shall only be delivered upon verification of the winning participant's identity through valid identification documents, such as an ID card or passport, and the signing of the necessary documentation.
- 10. Failure to Deliver: The Saudi Tourism Authority shall not be held responsible for the loss or failure to deliver the prize to the winner, and no compensation shall be provided.
- 11. Non-Transferability: Prizes are non-transferable and non-exchangeable.
- 12. Confidentiality: The participant shall maintain the confidentiality of any information classified as "Confidential Information" disclosed to him/her in connection with the award.
